#### **BWF Ranking**

- BAI & BWF eligible ranked players should send their entries through the respective Members
  Associations before the last date of entries.
- In case of absentees further ranked players are not eligible in their quota.
- The Host .Association is eligible to participate in this year's Team Championships.
- The seeding will be given as per BWF and BAI.

#### Mixed Team Championship

Inter-Zonal Inter State Team Championship shall be played in following sequence:

Men's Singles Women's Singles Men's Doubles Women's Doubles Mixed Doubles

#### **NOMINATION OF TEAMS FOR A TIE (TEAM EVENT)**

- No player shall play in more than two events.
- 2. Each competing Member Association is responsible for determining the criteria and method of selecting players for nomination, and for nominating players, to represent its Association.
- 3. Each Manager in the Managers' meeting shall submit nomination of 3 Men's singles and 3 Women's Singles, 3 Combination of Men & Women's Doubles and 3 Combination of Mixed Doubles in order of team championships. The same ranking order shall be valid for all ties throughout the competition, subject to the maximum players of not more than 5 in each category. For example one player can be nominated in singles / doubles / Mixed Doubles but he or she can play only in two events. For combination purpose a player may be nominated in 3 events but he/she can participate in two events only. Referee is authorized to take the final decision with the consultation of respective Manager. In doubles, each team shall play its one pair according to the previously submitted ranking order.
- 4. No substitution of player/pair shall be permitted under any circumstances once the team nominated for the competition.
- 5. Each tie shall be decided by the best of 5 matches as follows.

One Men's Singles One Women's Singles One Men's Doubles One Women's Doubles One Mixed Doubles.

6. Each Manager shall handover the players nomination form to the Referee as per the order of merit during Managers meeting. (With pair combination). Play in each tie shall be stopped when the tie is decided.



- 7. No substitution shall be permitted by the Referee after the draw is completed.
- 8. Play in each tie shall be stopped whenever the tie is decided with 3 matches. It may be 3-0, 3-1 or 3-2 matches.
- 9. A player withdrawn in singles in the following ties is permitted to participate in pair event in the same tie.
- 10. Any change of sequence in order of play in the following tie shall be informed to the Referee in writing before two hours of the commencement of the tie. (1st or 2<sup>nd</sup>). Otherwise, the Referee will continue with order of sequence submitted by the Manager during Managers meeting before commencement of Tournament.
- 11. The Referee shall inform such changes to the opponent team immediately
- 12. Players withdrawn in one tie is permitted to play in the next tie.
- 13. Any player participating in two matches is entitled to a minimum interval 'of 20 minutes between them.

# **Entries Closing Date**

#### : 1st February 2023.

The Entries shall be received by BAI as per the existing system with a copy to Org. Secretary. The entries are to be received through **Affiliated Units only** at **entry@badmintonindia.org** (Direct entries from the Players will not be accepted)

#### **Mode of Competition**

All matches shall be played on best of three games of 21 points in rally point system.

#### Regulations

:: The BAI Competition Regulations and General Competition Regulations shall be applicable. In the event of any dispute, the decision of the Tournament Referee will be final.

#### Clothing Regulation

Players must comply with Regulations as per norms.

#### **Main Draw List**

: First Main List will be published on 8th February 2023.

The list of participants in order of strength will be displayed on BAI website. It shall be the responsibility of the affiliated units and the players to ensure that all the entries forwarded by the Affiliated Units appear in the published List. If there is any omission, the selected player/s concerned immediately should contact their State Units and the State Units immediately to inform BAI about the omission for proper rectification. After the Last date for withdrawals, no complaints shall be entertained for omission of any entry. BAI will not be responsible for any omissions of names thereafter.

#### Withdrawals

#### 12th February 2023.

If there are any withdrawals after the close of entries, it shall be intimated to BAI immediately by the Affiliated Units before the closing date of withdrawal.

#### Draw

Inter State Draw will be made on 21<sup>st</sup> February 2023 at Managers Meeting.

Individual Draw will be made on 23<sup>rd</sup> February 2023 at Managers Meeting in the Venue in presence of Organizers, Managers/Coaches of Affiliated Units and Players.

The fees for lodging protest of any kind shall be Rs. 1000/-This fees shall be retained by the Organizer of the event. Any protest shall be addressed to the Org. Secretary in writing within one hour after completion of the match or 4 hours before commencement of the match

TOURNAMENT NT COMMITTEE The President, BAI may nominate Three (3) Members to the Tournament Committee.

4 members shall be nominated by the Host Affiliated Unit.

Hon'ble President, Hon'ble General Secretary and Chairman, TC& Convenor TC, shall be the EX- officio Members of Tournament Committee.

**FACILITIES** 

The organizers shall be responsible to provide free hospitality to the participating players, officials from each member Associations as under:

The Host Affiliated Unit shall provide free Lodging & Boarding facilities for the Tournament days + One (1) day before. Lodging & Boarding shall be provided upto 12 Noon of the following day of the completion of the Tournament. Accommodation will be provided by the Organizers on twin sharing basis only.

Every Member Association team taking part in the Nationals shall be responsible for all expenses incurred for their travel and other incidental expenses. Local Transport shall be provided by the organizers.

Member Associations are requested to inform the travel details along with the list of members to the Organising Secretary well in advance for making suitable arrangements.

**EQUIPMENT SPONSOR:** 

As per contractual agreement with Yonex/Sunrise, some agreed amount of AS-30 Shuttlecocks will be provided for the tournament. Additional shuttlecocks, if required shall be purchased by the Organizer.
